### AN ORDINANCE

OF THE CITY OF WILKES-BARRE, PENNSYLVANIA AMENDING SECTION 19-209 OF CHAPTER 19 OF THE CODE OF ORDINANCES OF THE CITY OF WILKES-BARRE ENTITLED "OFFENSES, MISCELLANEOUS PROVISIONS."

WHEREAS, it is the desire and intention of the City Council to pass legislation within the City of Wilkes-Barre by amending Chapter 19 of the City of Wilkes-Barre Code of Ordinances.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF WILKES-BARRE THAT SECTION 19-209 OF CHAPTER 19 IS HEREBY AMENDED AS FOLLOWS:

CHAPTER 19 OFFENSES, MISCELLANEOUS PROVISIONS

ARTICLE XII. Quality of Life Regulations

DIVISION 1. PROPERTY MAINTENANCE RULES AND REGULATIONS

Section 19-209. Fines and Penalties.

QOL 010	Disposal of rubbish or garbage; dumping	\$500.00	48 hours
QOL-012	Littering or scattering rubbish	\$500.00	48 hours
QOL-015	Ownership presumption of waste, trash and/or recyclables for illegal dumping and illegal hauling	\$500.00	48 hours

### SEVERABILITY.
