**AN ORDINANCE**

**EXTENDING THE TERM OF EXISTENCE OF THE PARKING AUTHORITY  
OF THE CITY OF WILKES-BARRE**

WHEREAS, the City Council of the City of Wilkes-Barre, Luzerne County, Pennsylvania, by appropriate action heretofore caused to be incorporated on or about August 18, 1958, the Parking Authority of the City of Wilkes-Barre pursuant to the provisions of the Parking Authorities Act of June 5, 1947, P.L. 458, as amended, known as the "Parking Authority Law";

WHEREAS, the Parking Authority of the City of Wilkes-Barre, by Resolution dated May 28, 2019, has expressed its desire to extend the term of its existence; and

WHEREAS, it is the desire and intent of the City Council of the City of Wilkes-Barre to extend the term of existence of the Parking Authority of the City of Wilkes-Barre.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF WILKES-BARRE AS FOLLOWS:

SECTION 1. That in accordance with the provisions of the Parking Authority Law, the term of existence of the Parking Authority of the City of Wilkes-Barre is hereby extended for fifty (50) years from August 18, 2008, through August 18, 2058, unless sooner dissolved according to law.

**SEVERABILITY.**

The provisions of this ordinance are severable. If any part of this ordinance is declared to be unconstitutional, illegal or invalid, the validity of the remaining provisions shall be unaffected thereby. It is the intention of the City Council of the City of Wilkes-Barre that this ordinance would have been adopted had such unconstitutional, illegal, or invalid part not been included.

**REPEALER.**

All ordinances or parts of ordinances inconsistent herewith be and the same are hereby repealed. All ordinances not specifically amended hereby remain in full force and effect.
