INTRODUCTION:

The City of Wilkes-Barre Zoning Ordinance, as amended, Section 203, defines Nonconforming Structures and Nonconforming Use (Article 2, Page 2-18). Article 8 of the Zoning Ordinance more specifically defines and classifies nonconformity as well as the requirements for the procedural treatment of nonconforming uses and structures. The zoning ordinance is available for review on line (www.wilkes-barre.pa.us Select Services, Planning and Zoning and Zoning Ordinance Information). In general, nonconformity means a use and/or structure, or condition which does not comply with the applicable use and bulk requirements of the ordinance which (A) lawfully existed prior to the enactment of the zoning ordinance (File of Council No.18 of 2012) or (B) was due to an amendment of this ordinance or (C) received approval of a variance for the use or structure at some point in time. To properly determine the zoning district of your property complete and submit the application for zoning district determination. If you do not wish to pay the \$25.00 service fee to determine your properties zoning district, you may review the zoning map on line or review the zoning map on display in our office to determine your zoning district. IF YOUR USE OR STRUCTURE DOES NOT MEET THE REQUIREMENTS ESTABLISHED FOR THE ZONING DISTRICT IN WHICH IT IS LOCATED AND IT IS NOT DUE TO (A) (B) OR (C), THEN YOU SHOULD NOT SUBMIT THIS APPLICATION UNLESS YOU CAN PROVIDE EVIDENCE OF THE CONTINUED USE AND/OR STRUCTURE SINCE 2012. It is recommended that you review the definitions and Article 8 of the Zoning Ordinance prior to filing this application.

- 2. Include the Nonrefundable \$100.00 application fee payable to the City of Wilkes-Barre.
- 3. Property owner must complete and sign the application.
- 4. The original signed application must be notarized. (Photocopies not accepted)
- 5. Affidavits in support of the application should reflect ownership and residency timetables and be specific as to the use, buildings and timeframes relative to the property under question in order to be useful.
- 6. Incomplete applications will not be accepted.
