The City Council of the City of Wilkes-Barre met in Regular Session on October 27, 2022, at 6:00 p.m., in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania, for the purpose of general business.

The meeting was organized with Chairperson Beth Gilbert McBride in the Chair.

The Pledge of Allegiance to the Flag was given.

Councilman Mike Belusko read the prayer.

City Clerk Cathy Payne read a statement relative to Council's Rules and Procedures.

The Chairperson asked if there was anyone wishing to address Council on pending legislation.

<u>Sam Troy, Wilkes-Barre, PA appeared before Council relative to the healthcare Resolution.</u>

Mr. McCormick explained that the requirements of the healthcare are determined by Collective Bargaining Agreements, which were negotiated by a prior Administration, which lasts through this year. He said depending on the CBA there are deductibles and premium

copays. He said that this Administration is currently negotiating contracts with all four unions.

Mr. McCormick continued by saying that the RFP was put out and there were only two proposals returned, one from Highmark and one from Benticon. They included, pursuant to the RFP, a broker's commission. They came in at 7% and Risk Strategies negotiated it down to 3.2%. He added that whatever the brokerage fee was that was between those two parties and had no effect on the premium.

Angel Mathis, Wilkes-Barre, PA appeared before Council relative to the healthcare Resolution (contract length).

Mayor Brown told Ms. Mathis that this contract is for one-year. Next year the city will go out for another RFP.

PRESENTATIONS BY COUNCIL MEMBERS

Mr. Barrett said he was happy to see the Resolution referencing the Laurel Run and Mill Creek walls. He said there is a lot of unfinished work up there and he is hoping that some of the money can be used to address the problems at Laurel Run Creek near Motorworld. There is some erosion and creek wall issues in that area.

Mr. Barrett asked that a center line be painted on the newly paved Laird Street.

Mr. Barrett asked for an update on the therapy ducks on Stucker Avenue in Parsons. Mr. Barrett said there is also trash on the property and the city needs to get a handle on it.

Mr. Barrett said there is a month-old pave cut that needs to be addressed in the area of 1300 Scott Street.

Mr. Marconi said that residents in the area of the Mill Creek wall reached out to him and they are very pleased that the wall is going to be getting some attention.

Mr. Belusko thanked the Administration for taking care of the permit parking issue on Sterling Avenue.

Mrs. McBride asked for an update on the water issue at the corner of Northampton Street and Park Avenue.

Mrs. McBride said there was some utility work done on East South Street and South Sherman Street. She said it still hasn't been paved and it is really rough to drive on. She asked if the Administration can find out if there is a timeframe for when they are going to pave it.

Mayor Brown told Mrs. McBride that the Administration has been in contact with the utility companies. He hopes that it will be paved within the next week or two.

PUBLIC DISCUSSION

Greg Griffen, Chairman of Luzerne County Citizens Blight Committee, Swoyersville, PA appeared before Council to give an update on litter cleanups and the City's Block Captain Program.

Mrs. McBride thanked Mr. Griffen for organizing litter cleanups and helping to keep the city clean.

Mr. Marconi also thanked Mr. Griffen for all that he does for the city.

Angel Mathis, Wilkes-Barre, PA appeared before Council relative to squatters at 442-450 South Franklin Street, street cleaning/leaf pick up notices, and parking meters in turning lanes.

Mayor Brown told Ms. Mathis that the South Franklin Street properties are part of the city's Blight Remediation Plan.

<u>Jason Carr, Saylorsburg, PA appeared before Council relative to the response from police when his car was hit on Oak Street and the city allowing someone to live in a house without heat and hot water.</u>

Mr. McCormick said the property without heat and hot water is owned by Mr. Carr and it was posted by the city. The city does not have the jurisdiction to remove people from the property. The tenant is now out of the property and staying at a hotel with help from a social service agency.

Mr. McCormick explained that the process is, if the owner of the property has a problem with someone being inside their property and didn't know they didn't have gas for a year (but were still taking the tenants money) the owner has to call the police to have the person removed.

<u>Bob Kadluboski, Wilkes-Barre, PA appeared before Council relative to City Council's healthcare and State Representative Eddie Day Pashinski.</u>

Mrs. McBride told Mr. Kadluboski that his topic was not city business and it was inappropriate for a City Council meeting. She said it is not the time or place for a campaign speech.

<u>Delmar Guziewicz, Wilkes-Barre, PA appeared before Council relative to the LCTA benches, and public transit.</u>

Mrs. McBride asked if the LCTA is removing the current benches and replacing them.

Mr. Guziewicz said to the best of his knowledge there is some legal question over ownership of the benches; they have no interest in removing the benches entirely if the LCTA does have authority over that.

There being no further business to discuss the meeting adjourned at 6:55 p.m.
