Mr. Merritt moved to adopt the Consent Agenda (Resolutions).

The motion was seconded by Mr. Barrett and adopted by the following yea and nay vote:

PRESENTATION BY COUNCIL MEMBERS

^{*}Replacing Charles Luce (expired 12-31-98) and Ann Marie Mantione (10-22-12)

Mr. Barrett pointed out that the state roads in the area of Fridays Restaurant (Kidder/Scott Street) are falling apart. He asked Mr. Frati if he knew what PennDot's plans are for them.

Mr. Frati said that PennDot will have a meeting at the district office in Dunmore and share with the municipalities what their intentions are for the upcoming paving season. He said he will look into it and get back to Council at a later date.

Mr. Belusko asked Mr. Frati how the city's equipment held up during the recent snow storm.

Mr. Frati replied that for the most part it held up very well. He said some equipment was lost during the storm and a few pieces are not going to be put back on the street. He said if the city is fortunate enough to get some of the money reimbursed some of the equipment will be looked at and maybe repaired.

Mr. Belusko asked if Mr. Frati can ask PennDot if Carey Avenue will be on the paving list this year.

Mr. Frati said it was on the plan last year, but at the end of their budget season they determined it couldn't be done. They reallocated money last year to a project that they thought was more in need. He said that he will ask about it at the meeting.

Mr. Merritt said that he was given an article about a group that is into cleaning up the Laurel Run Watershed, which involves the creek running through North End. He said they would be more than willing to work with the city on cleaning up the sediment. He asked Mr. Frati if he would reach out to them and see if they could provide some kind of funding.

Mr. Frati said the city is working with that group right now on a number of projects.

Mr. Merritt asked if any of the work involves removing the sediment.

Ms. Zaykowski replied that going forward the city has some potential plans with this group. The first project that will be under way will be on Ross Street.

Mr. Brooks asked Mr. Frati if he knew how many calls DPW received and how many inquiries were submitted on the website relative to the recent snow storm.

Mr. Frati said he hadn't had a chance to check the website for the number of inquiries, but said DPW took hundreds of calls for snow removal.

Mr. Brooks suggested that the city update the website, so that when a citizen sends an inquiry they receive an automatic response back saying that the city received it. He asked the IT department to look into it.

Ms. Gilbert asked Mr. Frati for an update on the Raymond's Electric building on E. Northampton Street that was hit last year.

Mr. Frati said he has not heard anything on the property lately, but it is time for the city to address it again.

Ms. Gilbert told Mr. Frati that she heard someone is living in the old Park Place Building on the corner of Park Avenue and East South Street. The building is deplorable. She asked if someone would look into it.

PUBLIC DISCUSSION

<u>Ron Romanelli, Director of Public Works, appeared before Council to discuss the</u> recent snow storm and how his department handled it.

John Rushton, Wilkes-Barre, PA appeared before Council relative to a Night at the Races at his church.

James Walsh, Wilkes-Barre, PA appeared before Council relative to extending the time for speakers, report on district happenings, department heads not attending meetings, the American Flag and the 100th Anniversary of World War I.

Bob Kadluboski, Wilkes-Barre, PA appeared before Council relative to being thrown out of the last meeting, Department of Public Works, refinancing (Cozen & O'Connor being bond counsel), department heads not attending Council meetings, and being a spokesman for Louis Weihbrecht (owner of Outsiders Saloon) at next meeting.

John Suchoski, Wilkes-Barre, PA appeared before Council relative to Martin Luther King Day (becoming a city holiday) and not using PennDot during snow storms.

Elizabeth Britt, Wilkes-Barre, PA appeared before Council relative to the deterioration of the curbs on Flood Drive.

There being no further business to discuss the meeting adjourned at 6:46 p.m.
