The City Council of the City of Wilkes-Barre met in Regular Session on May 24, 2018 at 6:00 p.m., in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania for the purpose of general business.

The meeting was organized with Chairperson Tony Brooks in the Chair.

City Clerk Jim Ryan read a statement relative to Council's Rules and Procedures.

The City Clerk asked if there was anyone wishing to address Council on pending legislation.

<u>Tom Dombroski, Wilkes-Barre, PA appeared before Council relative to File of</u> <u>Council No. 4 of 2018 (CDBG 2018 Action Plan (demolition of 37, 46, 48 Murray</u> <u>Street).</u>

Mr. Dombroski was told to contact Director of Community Development Joyce Zaykowski regarding his request.

Sam Troy, Wilkes-Barre, PA appeared before Council relative to File of Council No. 4 of 2018 (CDBG 2018 Action Plan) (include tree planting and transportation for children to the public pool on the West Side) and File of Council No. 5 of 2018 (Sale or Lease of Real Property).

Mr. Brooks informed Mr. Troy that Wilkes University had a public meeting regarding the trees. They removed 50 trees and are planting more than 50.

Mr. Brooks added that there have also been talks with the Administration of reforming the Shade Tree Commission.

Attorney Collins explained that the amendment to File of Council No. 5 of 2018 is to formally codify their procedure for when they acquire and sell real estate.

Ms. Gilbert said the city can't transport kids to other city pools, but suggested he contact the County about it. They currently have a program where they bus students to Francis Slocum Park.

PRESENTATIONS BY COUNCIL MEMBERS

Ms. Gilbert reported the following:

- 1. A particle board desk on the South Street Bridge (sidewalk).
- 2. The fire damaged home at 311 East South Street. It needs to be secured.
- 3. High grass at the corner of Park Avenue and Northampton Street.
- 4. Potholes on the corner of East Northampton and Sheridan Streets (going down the hill).

Mr. Merritt told the Administration that there is high grass on North Washington Street at North Street.

Mr. Belusko said he received a phone call from the owners of Wet Paint. They said someone dumped a load of bricks (couple of tons) in the back of the building. He said he doesn't have the capability to remove them. He is asking for the city's help.

Mr. Wampole said they will look into it.

PUBLIC DISCUSSION

<u>Rick Voelker, Wilkes-Barre, PA appeared before Council relative to the half-way</u> <u>house in Parsons.</u>

<u>Denise Thomas, Wilkes-Barre, PA appeared before Council relative to problems</u> on Hutson Street, Lehigh Street, Ivy Lane and Park Avenue.

Mr. Brooks said he spoke with Mr. Wampole about having the Mayor, the Chief of Police and Commanders meet with the neighborhood in public. He said that St. Anthony's Church has offered to allow the city to use there hall for a community meeting. He said he would like to have people come out and work toward a Resolution.

<u>Christa Koter Langdon, Hanover Township, PA, owner of 77 Hutson Street,</u> <u>Wilkes-Barre appeared before Council relative to the problems on Hutson Street, Lehigh</u> <u>Street, Ivy Lane and Park Avenue and rules and regulations for opening a business.</u>

Mr. Brooks asked Mr. Wampole to check into the situation with the barbershop on Lehigh Street. He said the city closed it down on Stanton Street and it moved a few blocks and reopened on Lehigh Street.

Mr. Wampole said the Administration will discuss it with the City Attorneys to see what can legally be done.

Mr. Wampole told the residents from Hutson Street and the surrounding areas that he spoke with the Police Chief and the Commander relative to the issues in that particular neighborhood. He said it is on the city's radar and he can't disclose too much information at this time.

Linda Joseph, Wilkes-Barre, PA appeared before Council relative to the problems on Hutson Street, Lehigh Street, Ivy Lane and Park Avenue, making Lehigh Street a one way and the barbershop at 99 Lehigh Street.

Mr. Wampole told the residents of Iron Triangle if they see something report it.

Officer Bob Collins also told the residents to call 9-1-1 if they see anything illegal going on in their neighborhood. He added that he will be concentrating on the area.

Pam Elliot, Wilkes-Barre, PA appeared before Council relative to problems with properties on Park Avenue (150, 152, 154, 160, 165-167 - garbage, fire hazards, and loud music) and Hutson Street.

Jim Walsh, Wilkes-Barre, PA appeared before Council relative to the lack of American Flags in the city.

John Suchoski, Wilkes-Barre, PA appeared before Council relative to the situation on Hutson Street and the surrounding area, sober houses, and the old train station on Wilkes-Barre Boulevard (needs to be boarded up).

Mr. Brooks said he will call the owner of the train station and ask them to take care of that.

Ms. Gilbert told Mr. Suchoski that she has been researching legislation on sober houses that can be passed on a city level to address it.

Mr. Brooks announced that the next City Council meetings will be held on Monday and Wednesday, June 11th and 13th.

There being no further business to discuss the meeting adjourned at 7:10 p.m.
