CITY COUNCIL

OCTOBER 4, 2018

The City Council of the City of Wilkes-Barre met in Regular Session on October 4, 2018 at 6:00 p.m., in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania for the purpose of general business.

The meeting was organized with Chairperson Tony Brooks in the Chair.

The Pledge of Allegiance to the Flag was given.

City Clerk Jim Ryan read a statement relative to Council's Rules and Procedures.

The City Clerk announced that the third Resolution on the agenda related to appointments to the Parking Ticket Appeals Board will be removed from the Consent Agenda (Resolutions) in favor of three Resolutions to be voted on separately.

The City Clerk asked if there was anyone wishing to address Council on pending legislation.

<u>Bob Kadluboski, Wilkes-Barre, PA appeared before Council relative to the Resolution appointing members to the Parking Ticket Appeals Board. (Marcella Lendacky)</u>

Sam Troy, Wilkes-Barre, PA appeared before Council relative to the Resolution appointing members to the Parking Ticket Appeals Board and the Resolutions authorizing the purchase of fire equipment (ambulance and miscellaneous equipment from Friedman Electric).

Deputy Chief Klapat explained that the City participates in the Pennsylvania COSTARS program. It is a cooperative purchasing program that guarantees municipalities the lowest price on equipment, vehicles and several other items. He said they received quotes from two different manufacturers (there are only two in the country) that provide the type of ambulance the city was looking for. The two quotes were relatively close and the city went with the lower one.

Deputy Chief Klapat told Mr. Troy that Friedman Electric is also a COSTARS participant. The city will be purchasing power tools and hand tools for the Rescue Truck.

PRESENTATIONS BY COUNCIL MEMBERS

Mr. Barrett expressed his concerns with the Fire Department patrols. He said he believes that it is misuse of equipment and staff. The equipment is not designed to patrol the streets.

Ms. Gilbert asked for a "No Parking This Side of Street" sign next to 243 South Sherman Street.

Ms. Gilbert reported the following:

- 1. Garbage between 31-43 South Meade Street (between the houses).
- 2. Leak on the corner of Howard and South Sherman Street causing water to accumulate on the road.

Mr. Merritt asked the Administration if they could check on putting a storm drain in at the corner of North Pennsylvania Avenue and East Chestnut Street.

Mr. Belusko reported an empty lot filled with garbage in the vicinity of 120 Carlisle.

PUBLIC DISCUSSION

John Suchoski, Wilkes-Barre, PA appeared before Council relative to the Fire Station on High Street (how often is it closed) and the Fire Department patrols.

Deputy Fire Chief Alan Klapat informed Mr. Suchoski that South Station is "browned out" when there isn't enough staff to staff the fire engine. He mentioned that most recently it has been "browned out" 90% of the time, due to retirements, long-term injury, illness and different types of leave. He also told Mr. Suchoski that as far as the Community Fire Watch, fire engines do have an option of either driving through the neighborhoods or they can park the truck and get out and walk around the neighborhoods. He said it is a very open policy. They are mandated by the Mayor to be out 24 hours a day 7 days a week.

Adam Cottle, appeared before Council relative to the Decriminalization Ordinance (2016) (police enforcement).

Ms. Gilbert suggested that he meet with Commander Coffay to discuss it.

<u>Karen Komorek, Wilkes-Barre, PA appeared before Council relative to getting a stop</u> <u>sign at Charles and Academy Streets. (Traffic Committee denied it).</u>

Mr. Belusko said they were supposed to install some signage, but nothing was done.

Attorney Henry said he will check with Mr. Harris.

Mr. Brooks said he will be in touch with her.

Sam Troy, Wilkes-Barre, PA appeared before Council relative to the Act 47 Hearing held in August (Why Council members present did not speak), creating a committee to discuss budget problems, retiring of Jim Hayward, and passing an Ordinance that would prevent an employee once he/she is dismissed or resigned from a position from coming back in another position.

Ms. Gilbert told Mr. Troy that when she went to the Act 47 meeting she was not sure what the format was going to be, so she didn't prepare a statement, but she said she did submit a written testimony. Ms. Gilbert added that Representative Pashinski and Senator Yudichak also submitted written testimony.

Mr. Merritt explained that the Administration told Council that the city met 2 or 3 criteria out of 11 to qualify for Act 47, so he thought it was a done deal and that the meeting was for public comment.

Mr. Belusko said that he spoke with Administration daily about filing for Act 47.

Bob Kadluboski, Wilkes-Barre, PA appeared before Council relative to the Fire Department/fire watches, former Mayor Tom McGroarty's involvement with the fire department, retirement of Jim Hayward (pension) and investigating the pension system.

There being no further business to discuss the meeting adjourned at 6:45 p.m.
