The City Council of the City of Wilkes-Barre met in Regular Session on November 20, 2018 at 6:10 p.m. (immediately following the Work Session), in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania for the purpose of general business.

The meeting was organized with Chairperson Tony Brooks in the Chair.

City Clerk Jim Ryan read a statement relative to Council's Rules and Procedures.

The City Clerk asked if there was anyone wishing to address Council on pending legislation.

<u>Bob Kadluboski, Wilkes-Barre, PA appeared before Council relative to the Mayor's</u> proposed 2019 General Fund Budget (lowering elected official salaries, Mayor's healthcare (Medicare), legal cost regarding the police department and pensions).

Mr. Barrett said it was his understanding that when an employee reaches Medicare eligible age that they automatically go on it.

Mr. Kittrick told Mr. Barrett that it depends on the date of hire.

<u>Tom Dombroski, Wilkes-Barre, PA appeared before Council relative to the Mayor's</u> proposed 2019 General Fund Budget (structural issues, selling the golf course and Park N' Lock East, Tax Anticipation Note, consolidate with other municipalities, layoff daytime EMTS, refinancing (50 years), Times Leader Building and pensions (hire Morgan Stanley).

John Suchoski, Wilkes-Barre, PA appeared before Council relative to the Mayor's proposed 2019 General Fund Budget (reducing the Mayor's salary), renaming Mayflower Park and the demolition of properties on Murray Street.

RESOLUTIONS

The following Resolutions appeared on the Consent Agenda (Resolutions):

RESOLUTION NO. R0109-18

Whereas, on October 8, 2018, the City of Wilkes-Barre said goodbye to life long city resident Brian Grohowski, who resided in the Mayflower section of Wilkes-Barre.

Whereas, Grohowski and his wife, Maureen, dedicated their time to give back to the community through the Jarad Grohowski Foundation, named after their late son.

Whereas, Grohowski annually held a free football clinic at Wilkes-Barre Memorial Stadium during the summer and provided local athletes the chance to attend a one day football camp out of the area at their cost.

Whereas, Grohowski's presence and community efforts will be deeply missed in the City of Wilkes-Barre.

Now, Therefore, Be It Resolved that the proper city officials are hereby authorized to change the name of Mayflower Park (a/k/a Huber Park) in the Mayflower section of Wilkes-Barre to Brian Grohowski Memorial Park.
