The City Council of the City of Wilkes-Barre met in Regular Session on January 10, 2019 at 6:00 p.m., in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania for the purpose of general business.

The meeting was organized with Chairperson Mike Belusko in the Chair.

Mr. Gazenski appeared before Council to introduce the following new item:

A Resolution to execute the appropriate agreement with the DEP, along with any and all other project documents, related to the new curbside residential recycling containers and the new leaf vacuum machine.

Mr. Gazenski explained that DEP has awarded the city with a grant \$350,000, with a 10% match from the city, for the purchase of recycling containers for every household in the city and the purchase of a leaf vacuum truck.

City Clerk Jim Ryan read a statement relative to Council's Rules and Procedures.

The City Clerk asked if there was anyone wishing to address Council on pending legislation.

Sam Troy, Wilkes-Barre, appeared before Council relative to File of Council No. 1 of 2019 (CDBG), the Resolutions accepting the proposal of Joyce Insurance Group and using the remaining balance in the Hollenback Verizon fund for the netting at Hollenback Golf Course.

Mr. Belusko explained that Verizon gave money to the city to be held in an account to be used for recreation.

Attorney Henry said this happened several years ago. He said he wasn't sure of the amount, but the city was ordered by the court to keep it in a separate fund to be used for recreational purposes. Over the years, when various needs arose for different parks, the city would use money from that account.

Ms. Zaykowski explained that the Ordinance is an adjustment to the 2018 OCDB Budget. There is a revolving loan fund that was set up over 20 years ago and that fund was to be used for businesses to come into the city and it provided them low interest loans. That particular program hasn't been used in about 15 – 18 years. The money that goes into that account is actually from a loan that was provided to the city (the most current money) by the parking lot across the street. In order for the city to be able to use that money, the budget has to be revised and the money needs to be allocated somewhere that it can be spent in a very quick timeframe (by October). This will allow the city to add two line items; a ladder truck and an additional fire truck.

#### PRESENTATIONS BY COUNCIL MEMBERS

Ms. Gilbert asked if South Sherman Street between East Northampton and South Street is slated to be paved.

Ms. Zaykowski replied that it is on the list for paving.

Ms. Gilbert said that in the meantime, there is a bad pothole on the corner between South Sherman and East Northampton Street by McCarthy's Tavern. She asked that DPW patch it temporarily until it could be paved.

Mr. Belusko told Council that he asked the Mayor to attend Council meetings, which he declined, just as he did in 2016, 2017 and 2018. He said then he asked the Mayor to meet him half-way and come to Work Sessions. The Mayor agreed and will be attending those meeting in the future.

#### **PUBLIC DISCUSSION**

<u>Greg Griffen, Opioid Citizens Committee, Swoyersville, PA appeared before Council to give an update on the Opioid Committee and a Drug Task Force.</u>

John Suchoski, Wilkes-Barre, PA appeared before Council relative to the city cemetery (clean up), city golf courses (do they make the city money), Verizon Tower in Hollenback Golf Course and paving Almond Lane (work done by the water company).

Ms. Gilbert said she will follow up with the Water Company on the work done on Almond Lane.

Mr. Belusko told Mr. Suchoski that golf does not make the city any money; it's more recreation for the residents.

Attorney Henry said it is a good idea to get volunteers to clean the cemetery, but it may subject the city to a grievance from the union.

Sam Troy, Wilkes-Barre, PA appeared before Council relative to the newly imposed Stormwater fee (WVSA), budget issues and the Revenue Enhancement Committee.

There being no further business to discuss the meeting adjourned at 6:32 p.m.
