CITY COUNCIL

September 14, 2023

The City Council of the City of Wilkes-Barre met in Regular Session on September 14, 2023 at 6:00 p.m., in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania, for the purpose of general business.

The meeting was organized with Chairperson Mike Belusko in the Chair.

The Pledge of Allegiance to the Flag was given.

Council member Bill Barrett read the opening prayer.

City Clerk Cathy Payne read a statement relative to Council's rules and procedures.

Ms. Payne read the following announcement:

The City Council Agenda has been amended to include a Resolution on the Consent Agenda regarding this year's Oktoberfest on Public Square. The Resolution will suspend the open container law. The reason for the amendment is that the event is September 30th and Council does not meet again before that date. Act 65 of 2021 states that Council may take official action on a matter if a majority of the governing body formally approves the amendment of the agenda to include the additional matter.

Ms. Payne asked for a motion and a second to amend the agenda to add the Oktoberfest Resolution.

Mr. Belusko moved to amend the Consent Agenda (Resolutions/Minutes) to include the Oktoberfest Resolution.

The motion was seconded by Mr. Barrett and the Resolution was added to the agenda by the following yea and nay vote:

Yeas Marconi, Gilbert, Barrett, and Belusko (Chairperson) – 4 – being a majority of the members elected to City Council.

The Chairperson asked if there was anyone wishing to address the Council on pending legislation.

Angel Mathis, Wilkes-Barre, PA appeared before Council relative to the LSA grant applications (Wilkes University and the Sherman Street Properties).

Mr. Barrett explained that these applications pass through the city to the state and there is no guarantee that any of the applicants will receive funds.

Mr. Barrett added that if the applications are not approved by the state, the applicants are not under any obligation to do anything.

Jessica McClay, Wilkes-Barre, PA appeared before Council relative to the LSA grant for the Sherman Street Properties Business Center Roof Replacement (profitable business) and are the applications reviewed before sending them through.

Mr. Barrett replied that each Resolution will be voted on; they are not automatically pushed through.

Sam Troy, Wilkes-Barre, PA appeared before Council relative to the addition of the Oktoberfest Resolution and the LSA grant applications (Bloxton Hotel Project and Wilkes University).

John Suchoski, Wilkes-Barre, PA appeared before Council relative to the LSA grant applications (campaign contributions from applicants/conflict of interest, Wilkes University grant, Bloxton Hotel Project, and do any applicants have contracts with the city).

Mr. Marconi said that he has not taken any campaign contributions from any of the applicants.

Ms. Gilbert informed Mr. Suchoski that she will be abstaining on two of the Resolution due to a conflict of interest (Luzerne Bank Building and Wilkes University).

Ms. Gilbert asked if anyone checked into the legality of passing a Resolution for an LSA grant for someone who has a contract with the city.

Mr. Barrett said he has no conflict of interest with any of the applicants. He said he did not know if the city having a contract with an applicant would preclude Council from approving the Resolution.

Ms. Gilbert said that it might be in the DCED guidelines.

Mr. Belusko said he would think that Grant Coordinator Mark Barry would know.

Ms. Gilbert said she doesn't feel comfortable not knowing that information. She said in the worst-case scenario, if Council finds out there is no conflict, a special meeting can be scheduled.

Mr. Marconi said that he too is not comfortable voting on it without that information.

Mr. McCormick said it would be a question for DCED, so if the application goes down, Council is just saying as a city, they support the application to be submitted. DCED would then have to review it and make a decision.

PRESENTATION BY COUNCIL MEMBERS

Mr. Marconi reported brush coming over the guardrails on Court Street and a fire hydrant covered by grass. He also mentioned that there is no stop sign on the way out of Court Street.

Ms. Gilbert said she thinks it is great that the Administration is applying for LSA funding for two major projects in the city, but she asked that the Administration apply for more funding to make improvements in the neighborhoods.

Ms. Gilbert asked the Administration how much of the American Rescue Plan Funds the city has left.

Mr. McCormick said there are still on-going projects, so he doesn't have the exact number.

Mr. Barrett agreed with Ms. Gilbert on the city applying to do more local projects with LSA grants. He said he just spoke with Mr. Barry about the same issue. He said he would like to see the city apply to have sidewalks put in throughout the city where there are none.

Mr. Belusko distributed the Wyoming Valley Sanitary Authority report to Council. It shows what streets were cleaned and catch basins that were cleaned and replaced.

PUBLIC DISCUSSION

<u>Jessica McClay, Wilkes-Barre, PA appeared before Council for an update/status of the proposed BBQ Restaurant (South Wilkes-Barre) and the former Philly Subs in Mill Creek.</u>

Mr. Marconi said that he has been communicating with the Administration regarding Philly Subs and they have responded to his complaints (high grass and weeds, debris etc).

Mr. McCormick responded to Ms. McClay's questions about the BBQ Restaurant that was to open in the old Silk Mill. He informed her that last week the real estate closing company contacted him with some issues with the title (they needed clarification). That was the delay that was going on. They represent the lending institution, so it should be moving forward.

Angel Mathis, Wilkes-Barre, PA appeared before Council relative to installing railings on Public Square (Amphitheater area), the cost of police reports for seniors, and parking on South Franklin Street.

Mr. McCormick said he would have Rob Sliker from Parking Enforcement investigate the parking issues on South Franklin Street.

Mr. McCormick also said he would talk to Chief Coffay about the police reports for seniors.

<u>John Suchoski, Wilkes-Barre, PA appeared before Council relative to the location of the Hawkeye cameras and the First National Bank Building.</u>

Mr. McCormick said that the agreement for the First National Bank Building is still in effect. There was an issue with a major leak when they were about ready to close. The city is working to resolve that problem. The Attorney's Office will probably prepare an addendum acknowledging that the issue was resolved and putting an end date on the closing.

There being no further business to discuss the meeting adjourned at 6:48 p.m.
