CITY COUNCIL SEPTEMBER 22, 2023

Request a Luzerne County Local Share Assessment grant of \$300,000 from the Commonwealth Financing Authority of the Commonwealth of Pennsylvania to be used for the Irem Temple Restoration project. The funding will be used for general restoration costs of the Irem Temple located at 62 North Franklin Street, Wilkes-Barre, PA.

Request a Luzerne County Local Share Assessment grant of \$350,000.00 from the Commonwealth Financing Authority of the Commonwealth of Pennsylvania to be used for the Sherman Street Properties Business Center Roof Replacement.

Request a Luzerne County Local Share Assessment grant of \$900,000.00 from the Commonwealth Financing Authority of the Commonwealth of Pennsylvania to be used for the Wyoming Valley Art League Building Improvements. The funding will be used for construction of an elevator, handicap accessible restrooms, classrooms and other improvements as appropriate.

Request a Luzerne County Local Share Assessment Grant of \$300,000.00 from the Commonwealth Financing Authority of the Commonwealth of Pennsylvania to be used for the Little Theatre of Wilkes-Barre Roof Replacement and Exterior Improvements project. The funding will be used for the replacement of the roof and the repointing of the exterior brick facing on the building.

Request a Luzerne County Local Share Assessment Grant of \$131,000.00 from the Commonwealth Financing Authority of the Commonwealth of Pennsylvania to be used for the Osterhout Free Library New Restroom in the Children's Wing project. The funding will be used for construction of a safe, accessible, and family-friendly restroom that will serve over 16,000 visitors to the Children's Wing annually.

SEPTEMBER 22, 2023

The City Council of the City of Wilkes-Barre met in Special Session on September 22, 2023, at 12:00 p.m., in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania,

The meeting was organized with Chairperson Mike Belusko In the Chair.

The Pledge of Allegiance to the Flag was given.

The opening prayer was given by Bill Barrett.

Chairperson Mike Belusko asked if there was anyone wishing to address Council on pending legislation.

Ken Okrepkie, Regional Manager, Irem Temple Restoration Project, thanked the administration and staff for all their help on preparing the resolution for this restoration project. He asked for councils approval on this project which will revitalize one of Northeast Pennsylvania's most prestigious buildings, and bring it back to a premier entertainment venue. It is part of a historic preservation project but will also drive \$10 million in annual economic development. The project will bring the 36,000 square foot facility back to not only an entertainment venue but also a museum to represent the impact this community has had on the industrial revolution. The amount requested will be used to install an elevator and new windows, making the facility totally ADA compliant. He concluded by saying they have already raised over \$3.2 million dollars for this project to date. This project will be completed as soon as possible to bring the full benefits to the city of Wilkes-Barre.

Mr. Brooks said the restoration of this building is imperative to the city. It is the only building of its kind in all of America, it is a one-of-a-kind architectural gem. He is grateful to the committee that has taken the initiative to get the building restored. It will be another great asset to bring people into the city.

Mr. Marconi asked how the amount of \$10 million to the economic drive was determined.

Mr. Okrepkie said when they put together the business plan for the project, they compared this venue to other venues in comparable size in this area. (ex. Masonic Temple in Scranton). The comparison uses many factors besides the revenue for the building, and also takes into consideration that most people will also go to dinner, possibly stay in a hotel.

Mr. Dale Parmenteri, Secretary and Treasurer, Irem Temple Restoration Project, said there was also a study that was done by the Institute of Wilkes, that estimated revenue for the F.M Kirby center was \$9.8 million, and they compared their project to that, also comparing the Sherman Theater and Pennsylvania Theater as well. One advantage they have is that this venue will have a flat open floor, which no other venue has, this will allow trade shows, weddings, and other events.

The business center currently provides warehousing, retail, distribution, food service & automotive repair spaces for 10 commercial businesses. The center was vacant for the 10 years prior to its purchase in 2020.
