

November 21, 2023

The City Council of the City of Wilkes-Barre met in Regular Session on November 21, 2023, at 5:52 (immediately following the Work Session), in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania, for the purpose of general business.

The meeting was organized with Chairperson Mike Belusko in the Chair.

The Pledge of Allegiance to the Flag was given.

Council member Bill Barrett read the opening prayer.

City Clerk Cathy Payne read a statement relative to Council's rules and procedures.

The Chairperson asked if there was anyone wishing to address Council on pending legislation.

Angel Mathis, Wilkes-Barre, PA appeared before Council relative to the Wyoming Valley Habitat for Humanity Resolution, the King's College LSA grant application and the LSA Grant application for the Hazle Street Wall.

Bob Kadluboski, Wilkes-Barre, PA appeared before Council relative to the King's College LSA grant application and the 2024 General Fund Budget (Council's healthcare).

<u>Sam Troy, Wilkes-Barre, PA appeared before Council relative to the 2024 General Fund Budget (raises and revenues), and the King's College LSA grant application.</u>

John Suchoski, Wilkes-Barre, PA appeared before Council relative to City Council's healthcare, the Hazle Street Retaining Wall Repair Project and the King's College LSA grant application.

Mayor Brown explained that a \$250,000 LSA grant was secured last year for the Hazle Street Wall; if this LSA grant application is approved that will take the total to \$750,000 for repairs. The city has engineering studies being done to see which areas should be done first.

Mr. Barrett stated that the colleges have hundreds of people working at their institutions and thousands of students that live here and support businesses in Wilkes-Barre. The colleges are anchors downtown and they aren't going anywhere. The city needs to support them and if they have the opportunity to apply for some funding to assist them with the new program, he agrees with it.

Mr. Belusko agreed with Mr. Barrett and added that he wants to see the money come into the City of Wilkes-Barre.

Ms. Gilbert said that historically she always votes against LSA grant applications from local colleges. She said the reason she is against them is that she knows how much she paid in tuition, and she knows how much some of the administrative position earn. She said the fact that they can call themselves a non-profit has always bothered her. Ms. Gilbert said that it does not mean that she doesn't think the program is worthwhile, but her gut tells her that the program will come to fruition with or without the LSA funding. She applauded the mayor for bringing more focus on city issues, because she has been advocating for them for years.

Sam Troy, Wilkes-Barre, PA appeared before Council relative to the salary increases in the 2024 budget, Finance Officer's salary, ARP money to balance the budget, energy audit.

Mayor Brown explained that the city used the Salary Data Survey to determine Finance Officer Brian Swetz salary.

Bob Kadluboski, Wilkes-Barre, PA appeared before Council relative to the Finance Officer's salary, King's College LSA grant application, Council's healthcare, the City Clerk's salary, the Mines lawsuit (Tom Greco) and elected officials' pensions.

John Suchoski, Wilkes-Barre, PA appeared before Council relative to the Times Leader Building, King's College LSA grant application, and blighted properties.

Mayor Brown said that the city put together a blight property report the first year he was mayor and the Administration has been working through that report at addressing properties. The city has also become a member of the South Valley Landbank. The Administration looks at properties that could be rehabilitated through this landbank. Mayor Brown added that twenty-four properties have been demolished in the four years he has been mayor.

Angel Mathis, Wilkes-Barre, PA appeared before Council relative to using eminent domain for parking spaces or community gardens, parking on South Franklin Street, affordable housing and rent control.

Eugene Francis Wallace, Wilkes-Barre, PA appeared before Council relative to the need for more trash cans in the city and federal infrastructure money.

There being no further business to discuss the meeting adjourned at 6:51 p.m.
