The City Council of the City of Wilkes-Barre met in Regular Session on February 10, 2022, at 6:00 p.m. in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania, for the purpose of general business. (The meeting was conducted and streamed on YouTube for public viewing due to COVID-19).

The meeting was organized with Vice Chairperson Mike Belusko in the Chair.

## **PUBLIC DISCUSSION**

John Suchoski, Wilkes-Barre, PA, phoned in relative to the Genetti's Apartment Fire and if the apartments are current on their rental inspections.

Mr. McCormick stated they do not require a rental inspection, as they are considered a hotel, which does not get inspected on the normal two-year rental basis.

<u>Bob Kadluboski, Wilkes-Barre, PA phoned in relative to the City Council's salaries and health coverage.</u>

Mayor Brown replied that from what he has been informed by legal representative that the only way that could be changed is through the State Legislator. There is no one else that could decide or make changes to City Council's benefit package.

Gerry Reisinger, Kingston, PA phoned in relative to information that he sent to Council, meeting with the Army Corp of Engineers, his meeting with the Mayor of Kingston and concerns about Nesbitt and Kirby Park natural areas.

Mayor Brown told Mr. Reisinger that there was a meeting held yesterday with Chris Belleman, Executive Director, Luzerne County Flood Protection Authority, Jim Brozana, Consultant and the prior Luzerne County Engineer during the reconstruction of the levee system, Butch Frati, Director of Operations, Charles McCormick, City Administrator, Larry Newman, a Certified Urban Planner and Director of the Diamond City Partnership, John Mayday, Executive Director of the Riverfront Parks Committee and a Board Member on the Luzerne County Flood Protection Authority, Mr. Caparal, State Game Warden. The conditions of the parks that Mr. Reisinger identified were discussed. It was determined the current growth buffers the levee system and the roots minimize erosion. The wild habitat for mammals and birds would be endangered by hanging their habitat. The Army Corp of Engineers incorporated the nature area into the overall reconstruction plan for the levee system during the \$200,000,000 levee raising project. Removing the overgrowth will not solve anything and it will not improve flood protection but will increase the threat of flooding. Also, the city will continue to clean the pathways, spray for knotweed and clean the trash as needed, as outlined and recommended by Vincent Catrone, Urban Forester at Pennsylvania State University.

Mayor Brown added that he did tour the area with Police Chief Coffay and there were no homeless people or signs of homeless people.

Jason Carr, Livingston, NJ phoned in relative to the Mayor's response to Bob Kadluboski, Council's salary and healthcare benefits, better access to participate in the virtual Council meetings and deplorable road conditions.

Mr. Belusko stated that the meetings can also be viewed on a cell phone.

<u>Donald Belcastro, Wilkes-Barre, PA phoned in relative to City Hall's public access and the lack of parking.</u>

Mayor Brown responded that there was a recent meeting to address public parking and additional spots are being identified, these will be marked with a Visitors Only sign.

<u>Nicholas Wadas, Kingston, PA phoned in relative to the condition of Kirby Park (the whole park needing improvements).</u>

Mayor Brown replied that there are several initiatives happening at Kirby Park. He mentioned the special needs playground that will be installed by August. He said several paved concrete walkways have been added and the main entrance into Kirby Park (off Market St), the parking lot and also the restrooms are all being upgraded to ADA compliance. Mayor Brown also said there will be other upgrades throughout Kirby Park in the near future.

<u>Jim Burden, Wilkes-Barre, PA phoned in relative to the ice rink on Public Square and huge potholes by Coal Street Park and Casey Park.</u>

Mayor Brown replied that he has seen multiple people using the ice rink. Next season there will be ice skate rentals available. Mayor Brown said he feels that the ice rink is an investment for the City. He stated that the rink being synthetic makes it easy to remove when the season is over. He told Mr. Burden that potholes are being addressed with a soft patch for now due to the weather.

Steve Mocarski, Citizens Voice, phoned in relative to the Police Department new hires (are there eight vacancies or will they be retirees).

Mayor Brown responded that there will be some current retirements and also future retirements. He mentioned there will be a new Police Civil Service test this year to obtain candidates to fill vacancies.

<u>Sam Troy, Wilkes-Barre, PA emailed in regards to the use of the American Rescue Act</u> monies, the non profit agencies taking 10% administrative costs, the forgiveness of the small business loans and allowing extra time for property tax payments.

Mayor Brown replied that \$7.1 million dollars has been allocated back to the residents and business's in the City from the American Rescue Act. He further stated that the 10% fee the nonprofit organizations receive is in the guidelines from the American Rescue Act. Mayor Brown said, that along with the \$300.00 stimulus that residents received, the home remodel program is also available for up to \$7500.00. He said there is available funds for residents who want to purchase a home in the City. Mayor Brown spoke about the parking meter fee that was reduced by a \$1.00 an hour. These initiatives are helping the City residents and new businesses.

There being no further business to discuss the meeting adjourned at 6:48 p.m.
