CITY COUNCIL

APRIL 11, 2019

The City Council of the City of Wilkes-Barre met in Regular Session on April 11, 2019 at 6:00 p.m., in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania for the purpose of general business.

The meeting was organized with Chairperson Mike Belusko in the Chair.

The Pledge of Allegiance to the Flag was given.

The City Clerk announced that a new item regarding appointments to the Shade Tree Commission will be added to the Consent Agenda (Resolution) by unanimous consent.

City Clerk Jim Ryan read a statement relative to Council's Rules and Procedures.

John Stelmachowicz and Patrick Tigue with the U.S. Census Bureau appeared before Council relative to the importance of the 2020 Census.

Mr. Ryan told Council that Parking Meter Technician Dave Ouelette was in the audience to answer any questions regarding the Resolution authorizing the disposition of parking meter heads.

Mr. Merritt asked if there is any salvageable value.

Mr. Ouelette said the heads are obsolete. He said he could ship them to the manufacturer for them to look at, but fix them or not it will cost \$99 a head. The city would be paying that plus shipping costs. Mr. Ouelette told Council that the new heads are \$200 each.

The City Clerk asked if there was anyone wishing to address Council on pending legislation.

Sam Troy, Wilkes-Barre, PA appeared before Council relative to the following Resolutions - Restore Pennsylvania, temporarily suspending the open consumption of alcoholic beverages for the Fine Arts Fiesta and the appointments to the Shade Tree Commission.

Mr. Brooks thanked Mr. Troy for his persistence on reactivating the Shade Tree Commission. He said one of the things he would like the public to know is that the city is looking into, as part of the Shade Tree Commission, a funding mechanism from the Federal or State Government, where the city can help low-income senior citizens remove and replace their tree in the tree lawn with an appropriate urban tree.

Mr. Ryan gave Mr. Troy a copy of the original and current Ordinance, which established the Shade Tree Commission in 1966.

Ms. Gilbert also thanked Mr. Troy for being involved in the community and bringing the Shade Tree Commission to Council's attention.

RESOLUTION NO. R0025-19

Whereas, Pennsylvania must position its communities for success and position itself as a leader in the 21st century by investing in critical infrastructure needs that for too long have been neglected.

Whereas, to help build a better future for all Pennsylvanians, Restore Pennsylvania will invest \$4.5 billion over the next four-years in significant, high-impact projects throughout the commonwealth to help catapult Pennsylvania ahead of every state in the country in terms of technology, development, and infrastructure.

Whereas, Restore Pennsylvania will provide funding to bridge the digital divide, supporting the installation of infrastructure to bring high-speed internet to communities across the commonwealth and making Pennsylvania a better place to work, do business, and live.

Whereas, Restore Pennsylvania will provide funding to assist individuals who suffer sever weather-related losses and funding to help communities prepare for flooding and sever weather, upgrade flood walls and levees, replace high-hazard dams, and conduct stream restoration and maintenance.

RESOLUTION NO. R0026-19

Whereas, every ten years, Article 1, Section 2 of the United States Constitution mandates a count of all the people living in the United States and its territories.

Whereas, the 2020 Census will address every household in the nation with a simple questionnaire with the goal of counting everyone only once, in the right place.

Whereas, data obtained by the survey will be used to help determine how approximately \$675 billion will be distributed from the federal government to state, local, and tribal governments annually.

Whereas, up to \$2,000 of federal funding will be lost for each person not counted; as well as upwards of \$20,000 of federal funding lost every ten years.

Whereas, Census data ensures fair Congressional representation by determining ow many seats each state will have in the U.S. House of Representatives, as well as the redistricting of state legislatures, county councils, city councils, and voting districts.

Whereas, The 2020 Census creates jobs that stimulate economic growth and increase employment opportunities in our community.

Whereas, a complete count requires bringing together leaders from all communities of Wilkes-Barre City, so that everyone regardless of racial, social, or economic background is counted.

Whereas, Mayor Tony George has established the City of Wilkes-Barre Complete Count Committee, which is comprised of community leaders. The committee will collaborate with community members to ensure a complete and accurate 2020 Census count, through residents' awareness and education of the count's importance. The committee will assist residents to overcome cultural, economic, technological, or linguistic barriers to participating in the 2020 census.

Whereas, The City of Wilkes-Barre is committed to its residents contributing to an accurate 2020 Census which will ultimately benefit the residents of the community.

Now, Therefore, Be It Resolved, that the City of Wilkes-Barre hereby urges the residents of Wilkes-Barre City to be counted during the 2020 Census.

MINUTES

Mr. Brooks moved to adopt the Consent Agenda (Resolutions).

The motion was seconded by Ms. Gilbert and adopted by the following yea and nay vote:

Yeas Brooks, Gilbert, Merritt, Barrett and Belusko (Chairperson) – 5 – being all of the members elected to City Council.

Nays none.

PRESENTATIONS BY COUNCIL MEMBERS

Ms. Gilbert reported a pothole on East Northampton Street at the corner of South Meade Street.

Ms. Gilbert discussed a continuing problem with a generator running on Almond Lane. She said she is not sure if the property owner has been cited, she hasn't received an update. She mentioned that the Health Department and Code Enforcement were there to check into it, but she said she doesn't know what the result was. Ms. Gilbert said there are two Ordinances on the books that would consider it a nuisance at this point, and they should be fined \$1,000.00. Ms. Gilbert said it is the fourth time she has brought this issue up at a Council meeting and she expects them to be fined \$1,000 if possible.

Mr. Gazenski told Mr. Gilbert that he thought the issue was resolved. He said he will check into it first thing in the morning.

Mr. Belusko asked why the generator is running.

Ms. Gilbert said it is assumed that the man is living there and a rumor that he is trying to start a commercial car garage there (which would have to go in front of Zoning).

PUBLIC DISCUSSION

Angel Mathis, Wilkes-Barre, PA appeared before Council relative to the need for bike paths, restaurants putting tables on the sidewalks and blocking pedestrian traffic, sinkhole on sidewalk in front of the Citizens Voice and people smoking marijuana at the Intermodal Transportation Center and the Anthracite News Stand in the morning.

Greg Griffen, Citizens Opioid Committee, Swoyersville, PA appeared before Council to thank them for sending a letter to Attorney General Freed regarding the opioid epidemic (task force).

Ms. Gilbert thanked Mr. Griffen for everything he does with the committee.

John Suchoski, Wilkes-Barre, PA appeared before Council relative to a pothole near South and South Main Street, licenses for cats, and union negotiation (removing the residency requirement).

Mr. Ryan said that he sat in on some of the union negotiations and not all City Hall employees asked for the removal of the residency requirement.

Ms. Gilbert said there is no license required for cats in the County.

Mr. Gazenski explained the Trap, Neuter and Return process for feral cats.

Jason Carr, Wilkes-Barre, PA appeared before Council relative to city employees' retiree benefits, residency requirement for city employees, employees' pensions, street cleaning and audit of the pension system.

Mr. Gazenski told Mr. Carr that the City will have three street sweepers in the neighbors beginning next week. One is owned by the city and the other two the city will borrow from the Wyoming Valley Sanitary.

Jack Feddock, Wilkes-Barre, PA appeared before Council relative to safety concerns at the intersection of Dagobert, Carey Avenue and Old River Road. (his home at 65 Carey Avenue has been hit 3 times).

Mr. Belusko said he discussed the issue with the Mayor at Tuesday's meeting. The Director of Operation Butch Frati is going to have poles installed in front of the house.

Mr. Gazenski said the poles screw into the ground and if for some reason you don't want them there, they can be taken out.

Tony Thomas, Wilkes-Barre, PA appeared before Council relative to the removal of the residency requirement for City employees (loss of earned income) and trash removal (regulations/license for private haulers).

Ms. Gilbert told Mr. Thomas that the garbage receptacle he showed her earlier is not in compliance with city code. Anything that is storing garbage has to be in a certain type of container.

Mr. Thomas said the container is a makeshift dumpster held together with plywood and bungee cords.

Ms. Gilbert said the Health Department did go to look at it. She said she hasn't received a response from them, but she will follow up and get back to him.

Angel Jirau, Wilkes-Barre, PA appeared before Council relative to creating a civilian police academy and a Civilian Review Board.

Sam Troy, Wilkes-Barre, PA appeared before Council relative to lack of transparency, Sterling lot, police officers' lawsuit against the city (how much was spent and why the City Attorney's Office did not take up the defense), and union negotiations (appoint Council member to negotiate).

Mr. Belusko told Mr. Troy that Council members are not involved in union negotiations.

Attorney Henry explained that the allegations made by the police officers against the city are alleged constitutional violations; which means that the lawsuit is picked up by the city's insurance company. The insurance carrier appoints the lawyer who defends the city in that case, and the city is only responsible for the deductible.

There being no further business to discuss the meeting adjourned at 7:23 p.m.
