July 18, 2019

The City Council of the City of Wilkes-Barre met in Regular Session on July 18, 2019, at 6:00 p.m., in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania for the purpose of general business.

The meeting was organized with Chairperson Mike Belusko in the Chair.

The Pledge of Allegiance to the Flag was given.

The City Clerk announced that the location for the Traffic Signal Approval Resolution is at the intersection of Franklin and Northampton Streets. He said it also improves the existing traffic light at that particular location. This information was missing from the Resolution presented on Tuesday at the Work Session.

Mr. Ryan asked if there was anyone wishing to address Council on pending legislation.

<u>Bob Kadluboski, Wilkes-Barre, PA appeared before Council relative to the Resolution appointing Mike Belusko to the Wyoming Valley Sanitary Authority.</u>

City Clerk Jim Ryan read a statement relative to Council's Rules and Procedures.

Jerry Lynott, Times Leader, Wilkes-Barre appeared before Council relative to the appointments to the various boards and authorities (did George Brown contact Council to ask them to vote no on the appointments).

Jim Burden, Wilkes-Barre, PA appeared before Council relative to the Resolution accepting the 2019-2020 Winter Services Agreement (incoming Mayor should sign the agreement).

<u>Angel Mathis, Wilkes-Barre, PA appeared before Council relative to the following Resolutions:</u>

- 1. Purchasing vehicles for the Police Department (do we need them and was there an RFP).
- 2. Multimodal Transportation Fund Grant Scott Street Streetscape and Carey Avenue Streetscape Improvement Projects (More details needed).
- 3. Purchasing LifePak 15 cardiac monitor/defibrillator (Was there an RFP).
- 4. The Industrial Sites Reuse Program Grant Times Leader Remediation Project.
- 5. Appointments to various boards and authorities (Do they get paid for serving).

Ms. Gilbert told Ms. Mathis that Council members can attend any board or authority meeting without being on the board.

Mr. Belusko said that none of the appointments to the boards and authorities are paid.

Mr. Belusko informed Ms. Mathis that the police vehicles and fire equipment being purchased are through COSTARS and negotiated to the lowest price.

Detective Casey explained that the 2019 Ford F-150 Responder is a police package pickup truck and it will replace a 22-year-old vehicle and it is specialty built for the rigors of patrol. It gives the police department the ability to support patrol operations effectively. This vehicle will assume a duel roll in supporting patrol operations, but it can also be used as a regular patrol car.

Mr. Merritt said his question is can these vehicles be purchased through Enterprise or are they specialty vehicles that they don't get involved with.

Detective Casey said that Enterprise will get involved, but they haven't engaged the Police Department as of yet. It is a phase in process.

Attorney Henry said it a couple of months Enterprise thinks they will be able to handle police vehicles, but at this point in time they are not.

Mr. Merritt asked if Council should pull the Resolution for a couple months and then see if Enterprise would offer something like this and save us money.

Detective Casey said that with respect to the pickup truck, that particular vehicle will have a 10 - 14-year life expectancy. The pickup is a vehicle that is stocked by the company we get our police cars from. Enterprise does not stock those cars. The last date to order those was July 5^{th} .

Mr. Merritt asked if the vehicles that are currently being used would hold up until we could look at other options.

Detective Casey said they probably wouldn't. Every time the City uses the vehicle to tow the barricade trailer something goes wrong. It is costing a lot in maintenance.

Mr. Merritt said he would like the Administration to start looking at leasing this kind of equipment in the future.

Attorney Henry mentioned that these purchases were already in the budget.

Ms. Gilbert asked if the Police Department could borrow a vehicle from DPW to transport the barriers.

Detective Casey said then the Police Department would not have the ability to use it as a patrol car. This purchase will supplement the patrol fleet when an extra car is needed.

PRESENTATIONS BY COUNCIL MEMBERS

Mr. Brooks discussed the following:

- 1. Delays in picking up yard waste.
- 2. Trash not picked up on Harkins Lane.
- 3. 3 large potholes on Griffith Lane.

Mr. Brooks commented on the fantastic turnout at the Rockin the River Event on Friday and encouraged everyone to attend this Friday's event. He complimented County employees Dave Pedri and Ted Wampole on their hard work in putting the event together.

Mr. Belusko said he also received several calls regarding the yard waste not being picked up.

Ms. Gilbert thanked the Administration for having South Sherman Street paved.

Ms. Gilbert said she is concerned about the condition of East Northampton Street. She asked if the Administration would look into a streetscape program for that street in the future.

Mr. Merritt said back in March he spoke with the Mayor about a problem behind Ralph and John Street. Over the guardrail is a hill that no one seems to know who owns. There are mattresses, garbage, and rodents running wild on the property. Mr. Merritt said he asked the Administration to find out who owns it, clean it up and send the owners a bill. He said he still hasn't gotten any answers on the ownership of the property and it has still not been cleaned up. He said the last he heard on the issue from Mr. Frati was that he thought the city needed to get volunteers to help clean it up. Mr. Merritt said he believes this is the city's responsibility. He would like the property cleaned up as soon as possible.

Mr. Barrett said after Tuesday's in-depth presentation by Chief Delaney and Chief Coffay regarding the 4th of July, specifically the firework situation he would like to propose a Resolution supporting House Bill 1687. He said the Fire Chief has been working with the Pennsylvania's Fire Chief Association and the Pennsylvania Municipal League to review the situation. He added that the House Bill is co-sponsored by Representative Pashinski. He asked Council to consider a proposed Resolution in support of House Bill 1687 addressing this issue and commending Representative Pashinski and asking all the other state legislatures to endorse this very important piece of safety legislation. He said this will give some control back to local municipalities and it increases the distance at which these types of fireworks can be discharged dramatically. He asked the City Attorney's office to draft a Resolution for the next meeting of Council.

PUBLIC DISCUSSION

Gene Stilp appeared before Council relative to the obscene brick on the monument on Public Square.

H, Hands of Hope Unmistakable Man of Color, appeared before Council relative to the First Amendment, racism and the (KKK) brick on the monument on Public Square.

Angel Mathis, Wilkes-Barre, PA appeared before Council relative to motorcycles & motorized bikes on city sidewalks, to thank the city for reaching out to businesses about signage on the sidewalk and trash not being picked up on Harkins Lane.

<u>Angel Jirau, Wilkes-Barre, PA appeared before Council relative to the (KKK) brick on the monument on Public Square.</u>

Jim Burden, Wilkes-Barre, PA appeared before Council relative to his dog getting hit by a car (thank you to those who helped, Whisker World, Animal Enforcement, Officer Steve Wengen and Council candidate John Marconi), installing curb dog signs, painting crosswalks and the (KKK) brick on the monument on Public Square.

Jeanne Magda, (5 Flood Drive), Wilkes-Barre, PA appeared before Council relative to water redirected from the soccer field to her home.

Ronald Felton and Dave Yonki, representing the NAACP Branch 2306, appeared before Council relative to the removal of the monument on Public Square.

John Rushton, Wilkes-Barre, PA appeared before Council relative to paving Scott Street.

Mr. Barrett said he spoke with Mr. Frati today and he said that Scott Street will be going out for bid soon. There is a lot of ADA and utility work that needs to be done before that can be done.
