

#### August 15, 2019

The City Council of the City of Wilkes-Barre met in Regular Session on August 15, 2019, at 6:00 p.m., in City Council Chambers, City Hall, Wilkes-Barre, Pennsylvania for the purpose of general business.

#### **RESOLUTION NO. R0061-19**

Whereas, a few years ago, Pennsylvania legalized the use of aerial fireworks by non-professionals;

Whereas, since then, Municipal officials and employees have dealt with numerous complaints from residents about danger and noise;

Whereas, in June of 2019, House Bill 1687 was introduced by State Representative Eddie Day Pashinski (and others) which would beef up regulations on the sale and use of fireworks in Pennsylvania, particularly the aerial fireworks which can be purchased by non-professionals.

Now, Therefore, Be It Resolved, that the City Council of the City of Wilkes-Barre hereby commends Representative Pashinski and other co-sponsors of the bill and urges our state legislators to support the passage of this important legislation which will protect city residents and their property from the dangers of commercial grade fireworks.

#### **RESOLUTION NO. R0062-19**

Whereas, the City of Wilkes-Barre Police Department requests authorization to apply for / obtain the 2019 Edward Byrne Memorial Justice Assistance Grant (JAG); and

#### PRESENTATIONS BY COUNCIL MEMBERS

Ms. Gilbert announced the rededication of Mayflower Park in honor of Brian Grohowski will take place this weekend.

Ms. Gilbert reported blue garbage bags out at the Park Place Building on the corner of Park Avenue and East South Street and pick up isn't until Wednesday.

Mr. Merritt reported a huge pothole on Scott Street, by EPSCO.

Mr. Barrett asked the Administration to follow up on 120 Custer Street. He said he received a second complaint about it. It is a property in disrepair and has high grass and weeds.

Mr. Barrett talked about Council's recent discussion about persons being able to carry firearms in Council Chambers. He said he sent information to everyone that he received from the Pennsylvania Municipal League that talks about legislation that limits Council's ability to restrict persons from coming on to government property with firearms; however there is another piece of legislation out there called Senate Bill 625, which was proposed by Senator Marie Collett, and it would amend that to allow municipalities to regulate firearms on municipal properties. Mr. Barrett said he reached out to Senator Yudichak's office and they are going to brief the Senator on our concerns to see if he would be receptive to getting behind this piece of legislation and moving it forward for a vote.

Mr. Barrett mentioned that the Pennsylvania League said they have received numerous inquiries across the state and a lot of municipalities are interested in this particular piece of legislation. Mr. Belusko reported a sinkhole at Gordon Ave Soccer Field (by the baseball field), on the playing surface.

#### **PUBLIC DISCUSSION**

<u>David Yonki, representing the NAACP, appeared before Council relative to the Multi-Cultural Parade scheduled for 9/14/19 and the Freedom Fund Banquet scheduled for October</u> 25, 2019.

Mary Ellen Jones, Wilkes-Barre, PA appeared before Council relative to aggressive dogs in the city (Ordinance stating that they have to be contained by a fence and/or leash).

Ms. Gilbert said there is an aggressive dog Ordinance on the books, so it might just be a matter of amending it.

John Marconi, Wilkes-Barre, PA appeared before Council to ask for an update on the new ladder truck for the Fire Department.

Mr. Gazenski said it has been ordered, but he didn't know when the city will take delivery.

Gene Stilp appeared before Council relative to the beehive monument removed from Public Square (looking for a donation of land (from private landowners) to put up a new monument).

Greg Griffen, Swoyersville, PA appeared before Council to give an update on the Opioid Committee.

Jason Carr, Saylorsburg, PA appeared before Council relative to Resolutions regarding agreements with the Pennsylvania Department of Health (Council not having answers to his questions), violence in the city and the status of the South Main / East Northampton Street property.

Ms. Gilbert told Mr. Carr that several months ago she spoke with Chief Coffay about the violence in the city. She said Chief Coffay has great leadership qualities and he is doing his best to take control of the city and the violence; however, the police need more funding. More funding needs to be allocated for public safety. She said the city needs more foot patrols and substations.

There being no further business to discuss the meeting adjourned at 6:49 p.m.
