PRESENTATIONS BY COUNCIL MEMBERS

Mr. Belusko recognized the Department of Public Works and Butch Frati for all their hard work after Monday's storm.

Mr. Barrett said he was amazed by how quickly DPW workers were out cutting trees up in the streets.

Mr. Marconi thanked the Administration for their handling of COVID-19 and the storm. He said the Mayor's updates on social media have been very helpful. He also thanked all city employees, especially the DPW crew and Butch Frati.

Mrs. McBride also thanked the first responders for everything they've done during the pandemic and gave a special thank you to Officer Shane Smith who has been called to active duty to assist with the COVID-19 pandemic.

Mr. Brooks also thanked the Department of Public Works and the Health Department for their hard work after the storm. He said Ross Street was a disaster and they cleaned up every scrap of paper. Also, there were two enormous trees that came down on West River Street and one on Jefferson Lane that were cleaned up quickly.

Mr. Brooks thanked the Mayor for keeping everyone informed through the media, tv, radio, newspaper and social media.

Mr. Barrett thanked the IT Director, Frank Hershberger for all his help with setting up the Council meeting and all of the Mayor's staff for their support.

PUBLIC DISCUSSION

The City Clerk read the following comments that were submitted via e-mail to the City Clerk's Office:

Jason Carr, Saylorsburg, PA:

Mayor Brown, not only are we in a medical and economic pandemic, as well, City Hall has been rendered disabled from a natural disaster and as of today, not a single person has been asked to voluntarily accept a furlough nor has anyone been directed to be laid off or furloughed from the city. How can the city afford these expenses when revenues will be delayed or stunted? Is it possible for you to contact Mayor Paige Cognetti and ask her advice on how she successfully furloughed 24 positions in her city hall and temporarily closed a fire station? How are the taxpayers of Wilkes-Barre to afford your decisions when they are not allowed to work?

When will the rest of City Council follow the lead of Councilwoman Beth Gilbert and accept a salary reduction considering the financial state of the city and its residents?

Mayor Brown replied that as of Monday ten people have been furloughed.

Sam Troy, Wilkes-Barre, PA:

Regarding the general comment portion of the meeting, I would like to know what the function of the Health Department is during the crisis? There was a recent article in the paper claiming that all the employees of that department, including three nurses, are working virtually around the clock to confront the pandemic crisis. I would like to know what exactly they are doing in that regard, because when I have called to ask where someone could get tested for the virus, all they could tell me is to go see my family doctor. I don't think this department is doing its job and I don't think it's essential to have these people on salary if they are not doing anything to mitigate this crisis.

Mayor Brown said that the paper did not say that all of the Health Department is working 24/7. It said some staff members are working 24/7. He said some of our nurses are engaged in doing that.

Mr. Radulski replied that the mission statement of the Health Department is to protect the health and safety of the residents of Wilkes-Barre. He explained that during a crisis the Health Department is an informational center. We receive approximately 60-70 calls a day on anything pandemic related. He said Mr. Troy has called several times and the people that spoke to him asked if he had symptoms and he did not. Mr. Radulski said the Health Department follows the CDC's credentials and criteria for testing. The Health Department fields calls from laboratories, shelters, long-term facilities, day cares and many people all hours of the day and night. He said the Health Departments emphasis is to control the spread of the disease. Our nurses do that by investigation; they want to find the origin of the disease, they want to isolate the disease and then they want to trace it to make sure it has not spread. He said the main goal in this pandemic with COVID-19 is to prevent the spread of the disease and with the team the Mayor has put together, we have actually made an effort in succeeding and flattening the curve in Wilkes-Barre.

Mr. Barrett said that we see the numbers every day across the country, around the world and across the state. The state numbers are broken down by county and Luzerne County's numbers are pretty high. He asked Mr. Radulski if there is a breakdown of where those numbers are coming from across the county (by city). He said he is curious to know if Wilkes-Barre has a significant number of those cases.

Mr. Radulski replied that the Wilkes-Barre City Health Department is responsible for everything in the City of Wilkes-Barre. He said we see numbers for the state and the county. The Health Departments' investigations are focused on people within the city who tested COVID-19 positive. We compilate those numbers and compare the city, to the county, to the state and focus on that.

Mr. Barrett said so the numbers aren't broken down by sections or areas.

Mr. Radulski said they only see the direct numbers for the City of Wilkes-Barre. The Health Department will plot every COVID positive person on a map and analyze any outbreaks, at any type of facilities, neighborhoods etc. We are all interconnected with one another, because a positive case for someone *working* in Hazleton or Pittston, that becomes our investigation because they live in Wilkes-Barre.

Mr. Brooks thanked Mr. Radulski, the Health Department and the frontline nurses.

Mayor Brown said the Health Department is doing an outstanding job. They deal with people on a daily basis and anyone that feels that they are not doing the job, he would

be glad to talk to and convince them differently. If someone doesn't understand what this department and other departments are going through with the pandemic, I think they have to be educated because they are working hard, and they are doing things that are out of the norm just to keep our residents safe.

Mayor Brown told the residents of the city that they need to see their physician for a test, not the Health Department.

Mr. Belusko thanked the Mayor, Mr. Radulski and Health Department for all of their hard work.

Mr. Belusko thanked his fellow colleagues that voted to reappoint Bob Hogan to the General Municipal Authority.

There being no further business to discuss the meeting adjourned at 4:52 p.m.
